#### INVESTMENT HIGHLIGHTS

**Conclusion:** Our final consumer cryptocurrency survey responses were a bit different than our early tallies but one of the most remarkable takeaways is that respondents would consider participating in an ALYI-led offering. Importantly, it is clear from the responses that it is the ALYI business approach regarding such a funding. In our view, this bodes extremely well for the Company, its stock, and the planned crypto offering. Moreover, it sends a message that with awareness comes support for ALYI.

**The Respondents:** While early participants skewed male, it took a major turn with the final tally of respondents skewing a slight majority female. We mention this because our sentiment going into the survey would be that men had a greater interest than women and may have been more familiar with the concept. Considering that about 50% or so characterized themselves as novices, this assumption proved accurate.

**Big Surprises:** Most participants were unaware that Facebook is planning to launch its own currency which we found shocking. Plus, less than 20% had an unfavorable view of crypto, yet nearly all felt it was the “wave of the future”, despite most having heard negative news from some sources, in general. All participants were familiar with Bitcoin.

**Most Important Takeaway:** Dovetailing with the novice nature, over 70% of respondents don’t plan to use/invest in crypto in the next twelve months. However, when presented with the (anonymous) ALYI concept and structure, around 20% replied that they would not be interested, with 80% open to the ALYI offering. Clearly, incorporating crypto to fund sustainable technology for use in helping emerging markets in need was well received and sends a powerful message to ALYI management and investors.
